I employ the Socratic method when I teach. I expect students to come to class prepared to discuss the work that had already been assigned – I do not cover all material from homework, but I add value to what was already studied. I use innovative assessment methods from classroom discussions to web-enabled, interactive quiz questions. Students who come to class unprepared will not fully benefit from learning exercises. Students will only get out of an educational

experience what they invest in it. If a student does not study, they will gain very little value. If a student augments the classroom discussion with diligent study, they will greatly benefit from the experience.
