Methodology

- Bilingual questionnaire was developed by a multidisciplinary team.
- Random selection of 500 households using Area Geográfica Estadística Básica (AGEB).
- Number of households per census was weighted based on population
- Interviewers were trained on the use of questionnaire and interviewing techniques
- Interviewers went to the south east corner of the AGEB and walked in a westerly direction, visiting every third house until the number of questionnaires assigned to that tract was achieved.
- Semi structured interviews were performed.
- An adult member of the household with the most recent birthday was interviewed.
- Interviews were conducted between 11 am and 7 pm to include the participation of the entire household and not just the homemakers.
- SAS program was used to analyze data.
